New Business:

Cluster Mailbox Repair: The post for the D Cluster Mailboxes has several holes caused by rust. After contacting Roger Duff, he agreed to replace the post on the D Cluster Mailboxes for \$50.00. The work was completed on Sunday, January 15, 2023.

NOTE: Harland Simmons provided the tubing for the post.

After discussion by the Board members, Carol Wainwright made a motion to reimburse President Meeks in the amount of \$50.00 for hiring and paying Roger Duff to replace the post on the D Cluster Mailboxes post; motion was seconded by Frank Moye. Members for 9, against 0, abstained 1. Proxies for 1, against 0, abstained 0. Motion passed unanimously.

Action Item 211 - Closed on January 21, 2023.

Repair to Portside Flag. The Portside flag was torn during the high winds. before the Christmas Holiday. The repair to the end was done by a seamstress at Roberson Laundry in Washington, NC. The repairs to the Portside flag were required to be paid in advance with cash only in the amount of \$15.00 paid by President Meeks. The flag repairs were completed and the flag flying again on Tuesday, January 10, 2023.

After discussion by the Board members, Lawrence Beacham made a motion to reimburse President Meeks in the amount of \$50.00 for the repairs to the Portside flag; motion was seconded by Carol Wainwright. Members for 9, against 0, abstained 1. Proxies for 1, against 0, abstained 0. Motion passed unanimously.

Any other new business:

Dead End Road Sign on Inlet Way Broken: Lawrence Beacham stated the Dead-End Road sign on Inlet Way was broken and needed replacing. After discussion by the Board members, Frank Moye made a motion to purchase a new sign from Hudson Signs in Chocowinity, NC not to exceed \$60.00; motion was seconded by Carol Wainwright. Members for 10, against 0, abstained 0. Proxies for 1, against 0, abstained 0. Motion passed unanimously.

Replace 2 old folding 8' tables at the Picnic Shelter: Frank Moye suggested that the Portside Board of Directors purchase 2 8' tables to replace the 2 old 8' folding tables for the Portside Picnic Shelter. Frank Moye stated currently one of the old tables has a bad leg. After some discussion by the Board members, Frank Moye made a motion to purchase 2 8' tables from Lowes not to exceed \$200.00; Lawrence Beacham seconded the motion. Members for 10, against 0, abstained 0. Proxies for 1, against 0, abstained 0. Motion passed unanimously.

Well, if you do that, starting Monday, October 1, 2012, you could be charged and fined. Officials say mandatory evacuations have always been mandatory. This new law makes it so officials can enforce it. People would face a \$1,000 fine and a misdemeanor charge if they are ordered to evacuate and don't.


