April 15, 2023

**Call to Order:** The quarterly Portside Homeowners Association Board of Directors meeting was called to order by President Meeks at 9:10 A.M.

Secretary's Business: Acting Secretary - Karen Simmons

**Record of voting members present:** Board Officers Present: President Frank Meeks, Vice President Lawrence Beacham, and Treasurer Mark Cutler. Board Members Present: Billy Braddy, Carol Anne Harrell, Frank Moye, Karen Simmons and Carol Wainwright.

**Board Officer's Absent:** Secretary – Mitch Manning

**Assignment of Proxies:** Mitch Manning's proxy assigned to Presiding Officer (Frank Meeks)., Tommy Poe's proxy assigned to Mark Cutler and Beverly Winstead's proxy was not valid.

**Confirmation of a Quorum:** There was a quorum present – Present 8, Proxies 2 and 1 proxy not valid.

### Other Business of the Secretary:

**Minutes of January 21, 2023 Board of Directors Meeting:** Members of the Portside Homeowners Association Board of Directors were asked if there were any changes to the draft minutes from the Board's meeting on January 21, 2023.

After some discussion, a motion was made by Lawrence Beacham to accept the minutes as submitted without changes; seconded by Carol Wainwright. Members for 8, against 0, abstained 0. Proxies for 2, against 0, abstained 0. 1 proxy not valid. Motion passed unanimously.

Minutes for March 4, 2023 Board of Directors Special Call Meeting: Directors were asked if there were any changes to the draft minutes from the Board of Directors Special Call meeting to review Portside covenants held on March 4, 2023.

After some discussion, a motion was made by Carol Anne Harrell to accept the minutes as submitted without changes; seconded by Mark Cutler. Members for 8, against 0, abstained 0. Proxies for 2, against 0, abstained 0. 1 proxy not valid. Motion passed unanimously.

Treasurer's Business: Mark Cutler

**Review of Quarterly Treasurer's Report for the Period January 1, 2023 – March 31, 2023:** Mark Cutler submitted the attached Treasurer's report (Enclosure 2) as of March 31, 2023. After the review was completed, Billy Braddy moved to accept the Treasurer's Report subject to audit of the income and expenses for the period January 1, 2023 – March 31, 2023; motion seconded by Frank Moye. Members for 8, against 0, abstained 0. Proxies for 2, against 0, abstained 0. 1 proxy not valid. Motion passed unanimously..

New Business of the Treasurer: Mark Cutler

Portside U.S. Income Tax Return Form for 2022: Mark Cutler informed the Board members that he filed the U.S. Income Tax return for the Portside Homeowners Association. Mark explained that with the \$51.52 interest Portside received from the Capital One account, we will pay \$ .00 in taxes.

Action Item 215 closed on April 15, 2023.

2023-2024 Homeowners Dues (July 1, 2023 – June 30, 2024): The members of the Board of Directors discussed e-invoice mailing and/or mailing an invoice to the Portside property owners for the 2023-2024 dues. Mark Cutler will have the dues invoices (sample at Enclosure 3) ready to e-mail and/or mail by May 1, 2023. Electronic copies will go to all members with valid email addresses. Paper copies will be mailed to members without email addresses. See Enclosure 4.

Action Item 216 opened on April 15, 2022.

**Projected Draft Budget for July 1, 2023 – June 30, 2024:** Mark Cutler presented the attached projected Portside Homeowners Association budget for July 1, 2023 – June 30, 2024 and explained the projected Income and Expenses. Mark reviewed items listed in the budget which need to be considered for capital improvements. After discussion by the Board members, Frank Moye moved to accept the projected Portside budget subject to the final approval at the Annual Homeowners meeting on July 8, 2023; Lawrence Beacham seconded the motion. Members for 8, against 0, abstained 0. Proxies for 2, against 0, abstained 0. 1 proxy not valid. Motion passed unanimously. **See Enclosure 5.** 

Action Item 217 opened on April 15, 2023.

**NOTE:** The projected Portside budget for 2023-2024 will be presented to the Portside Homeowners at the Annual Portside Homeowners Meeting on July 8, 2023 for the Homeowners approval. **Action Item 217** will remain open until the projected budget is presented on July 8, 2023 and approved.

Any other unfinished business of the Treasurer: None.

#### **Unfinished Business:**

Portside Sewer Petition Extension Update: No update to report now.

Action Item 78 - Ongoing.

Review of the Portside Bylaws and Covenants: At the Board of Directors meeting on January 21, 2023, Billy Braddy recommended we contact a lawyer to review our current Bylaws and Covenants. Frank Meeks and Karen Simmons presented and discussed the letter with Will Mayo in his office on February 10, 2023. On Thursday evening, February 16, 2023, we received the first draft of the suggested/recommended changes to the two Portside Covenants for the Board to review. After discussion by email, President Meeks called for a Special Call Board meeting on Saturday, March 4, 2023, for a detail face-to-face discussion. The Board's recommendations/comments were emailed to Attorney Will Mayo for review and incorporation into the Portside Covenants.

Action Item 200 - Opened on November 29, 2021.

On April 4, 2023, President Meeks received the revised changes to the two (2) Covenants from Will Mayo with the following two (2) added comments:

- 1. Fences: This new language is legally unenforceable as no measurable standard has been established.
- 2. Section 7: He did not add the 2% language as the statutes of NC accrue interest at 8% on judgments.

After some discussion, a motion was made by Lawrence Beacham to accept the revised changes as submitted with changes; seconded by Carroll Harrell. Members for 8, against 0, abstained 0. Proxies for 2, against 0, abstained 0, 1 proxy not valid. Motion passed unanimously.

**NOTE:** Any changes to the two Portside Covenants recommended by Will Mayo and the Portside Board will need to be approved by a 2/3 majority vote of the Portside Homeowners Association.

**Dead End Road Sign on Inlet Way Broken:** The Dead End Road sign approved at the January Board meeting was ordered from Hudson Signs in Chocowinity, NC. The cost was \$48.04. The new Dead End Road Sign was installed on January 30, 2023.

Action Item 213 - Closed on January 30, 2023.

Replace two (2) old folding 8' tables at the Picnic Shelter: The two (2) new eight (8) foot tables approved at the January Board meeting were purchased on February 9, 2023. The cost was \$182.50 (Cost includes a 10% military discount). The old two eight (8) foot tables were taken to the county dump site.

Action Item 214 - Closed on February 9, 2023.

Any other unfinished business: None.

#### **New Business:**

**Portside Financial Audit for July 1, 2022 – June 30, 2023:** The Board President stated that it was time to start preparing for the annual Portside Homeowners Association (HOA) financial audit. After some discussion by the Board of Directors members, President Meeks appointed Wes Crawford to conduct the July 1, 2022 – June 30, 2023 audit of the Portside HOA financial records. The audit will be presented at the Portside Annual HOA meeting on July 8, 2023 for approval. Attached as Enclosure 5 is the audit report format.

Enclosure 7 – Financial Audit Report. Action Item 218 was added on April 15, 2023.

Chairman of the Nominations Committee: President Meeks advised the Board members that this year five (5) seats on the Portside Board of Directors will be up for election. President Meeks appointed Karen Simmons as the Chairman of the Nominations Committee, and stated she can select two other members to help in the nominations selection. Following are the five (5) Board members whose term will expire on June 30, 2023: Frank Meeks, Mitch Manning, Billy Braddy, Tommy Poe and Karen Simmons See nomination report format attached.

There are no restrictions on the number of nominations. The election of the new Board members will occur during the annual Portside Homeowners meeting on July 8, 2023.

Enclosure 8 – Nominations Committee Report. Action Item 219 was added on April 15, 2023.

Following are the six (6) Board members whose term will expire on June 30, 2024: Lawrence Beacham, Mark Cutler, Carol Anne Harrell, Frank Moye, Carol Wainwright and Beverly Winstead.

**NOTE:** A special call Board of Directors meeting to elect new Board Officers will take place following the close of the annual Portside Homeowners Association meeting on July 8, 2023.

**Portside on the Pamlico Replacement Flag**: On February 21, 2023, President Meeks emailed the Portside BOD members with the following information and asked for a vote.

The cost of the original Portside on the Pamlico flag was \$188.32 made by Arkansas Flag and Banner, Inc. and put in service on November 16, 2020. The second Portside flag cost \$182.09 and was purchased on January 10, 2022.

Due to the high winds we had incurred in the last couple of months, the flag has been repaired twice (\$25.00 first time paid by Portside and \$10.00 the second time and paid for President). There is no way to shorten the length of the flag for future's repair without taking part of the anchor.

President Meeks received quotes for ordering 1 or 3 flags on February 21, 2022.

The cost of 1 Portside flag is \$224.67. The cost of .3 Portside flags is \$347.83.

The President's email serves as the motion to purchase 3 flags at a cost of \$347.83 and it was seconded by Frank Moye. Members for 8, against 1, abstained 1. Proxies for 1, against 0, abstained 0. Motion passed unanimously.

\*\*Closed on February 2, 2023.\*\*

**NOTE** New flags arrived on March 24, 2023.

**Repair Potholes:** President Meeks asked the board about purchasing bags of asphalt from Lowes to repair the pothole at 45/46 Riverview Drive due to the volume of traffic for the boat ramp and picnic shelter and the right curve as you enter Inlet Way. After discussion by the Board members, Frank Moye moved to purchase up to 12 bags if needed of QPR Asphalt pavement repair at \$16.28 per bag plus taxes; Carol Harrell seconded the motion. Members for 8, against 0, abstained 0. Proxies for 2, against 0, abstained 0. 1 proxy not valid. Motion passed unanimously. **Action Item 221 opened on April 15, 2023.**


